Form Instructions

A supplemental disclosure is required for internet game content providers applying for a supplier's license under the Lawful Internet Gaming Act.

For purposes of this form, "applicant" means a person who applies for a license under the Lawful Internet Gaming Act, and includes a company that, directly or indirectly, through 1 or more intermediaries, controls or is controlled by a person applying for a supplier license under the Lawful Internet Gaming Act.

For purposes of this form, "internet game" means a game of skill or chance that is offered for play through the internet in which an individual wagers money or something of monetary value for the opportunity to win money or something of monetary value.

For purposes of this form, "internet gaming" means operating, conducting, or offering for play an internet game.

For purposes of this form, "internet game content" means any hardware, software, applications, including mobile applications, and servers used to operate, conduct, or offer internet games.

For purposes of this form, "person" means an individual, partnership, corporation, association, limited liability company, federally recognized Indian tribe, or other legal entity.

The applicant should respond to the questions contained herein to the best of its knowledge. Any misrepresentation or omission may result in denial of your application for a supplier's license and/or disciplinary action, including, but not limited to suspension or revocation of applicant's provisional supplier's license.

The Board, at its discretion, may require the applicant to furnish additional information or documents based on the information provided in this supplemental disclosure of internet gaming activities, or as otherwise identified during the course of its background investigation.

The applicant has a continuing duty to disclose promptly any material changes in information previously provided to the Board as soon as becoming aware of such changes. The duty to disclose changes in information continues throughout any period of licensure granted by the Board.
